Comments on the Learning Outcomes

Feedback on the learning outcomes which were evidenced well and those which require more focus based on the portfolios submitted in this series.

LO's evidenced well: LOA with software and activities to promote learning.LOC specifying 21st Century Skills. LOE, G and H, demosntrating use of DT's and reflection for future development.

LOI, J, K, L with insufficient evidence, not using any of the DT's mentioned in LOH, with feedbacks and reflections only about strengths and no evidence of areas for further development. LOK specially weak with theories mentioned without application to own practice and discussions lack information on specific future implementations.

Comments on the Assessment Criteria

Feedback on the Assessment Criteria which were addressed well and those which require more focus based on the portfolios submitted in this series.

AC1 at a level of a Pass with some limitations and inaccuracies, sufficient to demonstrate a broad understanding of concepts and principles.

AC2 could have been at a level of a Pass however unit 3 did not represent an improvement, not completing the cycle of reflection in an spiral and with future developments and theories only mentioned rather than applied or linked.

AC3 with discussions rather descriptive despite using enough sources of information. There is a lack of evidence and examples and ideas are not specific.

Ac4 with significant weaknesses, opinions at length and a text with abundant grammar mistakes, difficult to follow in places.

14 MARAYANN JACINDA LAMBERT: Candidate demonstrates a broad understanding of concepts and principles, with some application to own practice. Some evidence of effective practice in unit 2, however, the application of theories is limited and reflections for future developments in unit 2 are not applied to developing unit 3. Unit 3 is descriptive rather than analytical, opinions without links to evidence or specific developments. Attempts of referencing to support ideas rather unsuccessful, with abundant grammar mistakes.
